

A. Selection of the GEAN award winners

- Nominated: 6 enterprises
 - ✓ Korea-based: LOTTE Rental, Korea Post
 - ✓ Overseas-based: BloombergNEF, BYD, Nissan, Renault
- Award winners selected: 2 enterprises
 - ✓ Nissan: LEAF EV / Launched the world's first mass-produced EV model in 2010; became the world's first EV model with 400,000 units sold as of late February 2019 (saved 3.8 million barrels of oil).
 - ✓ BYD: The world's No. 1 EV manufacturer

B. Acceptance of new board members

- Application received from 1 enterprise
 - ✓ Korea-based: Edison Motors Co., Ltd. (an EV bus manufacturer)
 - ✓ Representative: Youngkwon Kang, President



1. Report of the Decision from Board Meeting

C. Approval of the consolidated settlement of accounts for the fiscal year 2018

- Total income: ₩62,031,575 (approximately \$60,000)
 - ✓ Support from IEVE: ₩47,844,402
 - ✓ Kook-hyun Moon, a GEAN board member: ₩10,000,000 won (special membership dues)
 - ✓ Youngkwon Kang, President of Edison Motors, Co., Ltd.: ₩3,000,000 (general corporate membership dues)
 - ✓ Support for the speakers of IKW2018 from KOTRA: ₩1,170,760
 - ✓ Interest on deposits: ₩16,413
- Total expense: ₩57,399,666 won (approximately \$55,500)
 - ✓ 2018 GEAN board meeting, general meeting, ASEAN 10 countries EV forum: ₩47,466,908
 - ✓ Administration of the website (for 1 year): ₩836,000
 - ✓ IKW 2018: ₩5,970,158
 - ✓ Payroll for the secretary general/3 months: ₩2,868,000

D. Approval of organizing specialized working committees

- Ground: Article 4 of the Articles of Association
 - ✓ “Concerning the objectives of the Association” and “concerning the contents of the actions of the Association”
- Details: Upon the determination by the board members
 - ✓ Specialized working committees (e.g. standard committee, service industry committee, etc.) may be established and operated to conduct solid activities concerning the objectives of the Association and concerning the contents of the actions of the Association.



2. Key Achievements

A. MOTIE's authorization of the corporate registration of GEAN headquarter

- Ground: Article 2 Section 1 of the Articles of the Association
 - ✓ "The Association will be headquartered on Jeju Island, the Republic of Korea."
 - ✓ For the corporate registration of the GEAN headquarter (by the related government authority) so as to handle accounting matters under the laws of the Republic of Korea where the association is headquartered.
- Results: Corporate registration of the GEAN headquarter
 - ✓ Registration date: Jan. 31, 2019
 - ✓ Government authority: Ministry of Trade, Industry and Energy (the department related to the electric vehicle industry)
 - ✓ Official title: Global EV Association Network Headquarters
 - ✓ Location: Jeju Special Self-Governing Province, Republic of Korea
 - ✓ Representative: Daehwan Kim, chairman of the Global EV Association Network
 - ✓ Requirement: To abide by the laws of the Republic of Korea
 - ✓ Activities: Research and collaboration for tackling environmental and energy crises, with a focus on electric vehicles
- ✓ Upon the authorization, the corporate registration was made at the court.



B. Plan for the potential Pyongyang International EV Expo

- Ground: Decision from tentative board meeting (Nov. 5, 2018)
- Details: Upon the determination by the board members
 - ✓ Initiate discussion to host an EV expo in Pyongyang in a similar format to that of the IEVE
 - ✓ Initiate discussion to host an international EV conference and the GEAN general meeting in Pyongyang

 - ✓ On-going efforts such as
 - ❖ In-depth consultation has been made with the related South Korean ministries including the Ministry of Unification.
 - ❖ Consultation has also been made with the related North Korean authorities.

 - ✓ Plans for the future
 - ❖ During the period when only the personnel exchanges are possible with the ongoing sanctions, efforts will be made for the currently possible events, i.e. the Pyongyang International EV Policy Forum and the Pyongyang GEAN General Meeting According to the results of the consultation with the North Korean authorities.



2. Key Achievements

C. Plan for the potential EV Rally along the 1100 Road of Mt. Halla

- Ground: Decision from the board meeting
 - ✓ Initiated discussion with Jeju special government to host an EV rally on the Mt. Halla 1100 road in a semi-formal format during the 6th IEVE.
- Results: Final determination by the board members
 - ✓ The 1100 Road in Mt. Halla is designated as a national park under the Natural Parks Act and a natural reserve under the Cultural Heritage Protection Act.
 - ✓ It is also inscribed as a UNESCO World Natural Heritage site, a UNESCO Global Geopark site and a UNESCO Biosphere Reserve.
 - ✓ It was reviewed that
 - ❖ Safety facilities are not allowed in 1100 road in Mt. Halla under the afore-mentioned laws;
 - ❖ If hosted, the event will be criticized by the domestic and overseas environment groups, media and experts;
 - ❖ The event might not meet the objectives of the GEAN.
 - ✓ Hence, it was determined not to host the event.



3. Plan for Gangwon Global E-Mobility Forum


1. Plan to host Gangwon Global E-Mobility Forum

- Ground: MOU signed on March 18, 2019
 - ✓ GEAN Chairman and President of Gangwon National University (see Attachment 2) officially signed on the agreement.
- Key agreement:
 - ✓ GEAN will regularly host the Gangwon Global E-Mobility Forum (tentatively named) with Gangwon Province, which is trying to cultivated 'e-mobility' as its core industry.
 - ✓ Two parties agreed to hold a roundtable meeting during the second half of this year to specifically discuss the characteristics and the agendas of the forum, as well as the date and other detailed matters.
- Future plan: in consultation with Gangwon Province government
 - ✓ A roundtable meeting will be held during the second half of this year; the base plan for the next year's event will be confirmed, including its characteristics, scope and procedures; and
 - ✓ During the second half of next year, the 1st Gangwon Global E-Mobility Forum will be held.

- Host: MOTIE, Republic of Korea
- Organizer: GEAN / IEVE
 - ✓ The 1st Forum: Held in November 2018 / Seoul, Republic of Korea
 - ✓ The 2nd Forum: Held during the 6th IEVE (throughout May 9, 2019)
 - ✓ The 3rd Forum: Slated to be held in November 2019 / Seoul, Republic of Korea (planned)
- Key agendas: Building a network for exchanges of information and technologies between the leading EV and automated car makers and the new enterprises.

 - ✓ China and Japan hosted the 1st Trilateral EV Forum on May 10 (Fri.) at Halla Hall B
 - During China's Hangzhou International Expo:
 - ✓ In October 2019, Joint EV forum between ROK-PRC will be held.
 - During the China EV 100 Forum, slated to be held in Diaoyutai, Beijing:
 - ✓ In January 2020, ROK-PRC Joint EV Forum will be organized.
